Warranty information provided here applies to new units only and does not pertain to factory re-certified units. ANY IMPLIED WARRANTY OR MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, MADE WITH RESPECT TO THIS PRODUCT OR ANY OF ITS COMPONENTS AND ACCESSORIES IS DISCLAIMED AND REPLACED BY THE TERMS OF THIS WARRANTY.

Haiku Home warrants its lighting fixture to be free from defects in workmanship or material under normal use and service for seven years after the date of shipment to the customer. Haiku Home will repair or replace any equipment found to be defective during the warranty period. A fixture shall be deemed defective if greater than 15 percent of the individual light emitting diodes (LEDs) are not functioning as designed. Final determination of the nature and responsibility for defective or damaged equipment will be made by Haiku Home, working with any component vendor(s), if applicable.

This warranty only applies to Garage Series, and is limited solely to products purchased directly from Haiku Home or from one of its authorized dealers. Under no circumstances will warranty coverage extend to products purchased through eBay, Craigslist, or other internet auction or internet-based retail sites. Warranty coverage is contingent upon proper use in the application for which the product was intended and does not cover products which have been modified or repaired without Haiku Home's approval or which have been subjected to accident, improper maintenance, installation or application, or on which original identification marks have been removed or altered. This warranty also does not apply to interconnecting cables or wires, consumables or to any damage resulting from battery leakage.

In all cases our responsibility and liability under this warranty shall be limited to the cost of the equipment. The purchaser must obtain shipping instructions for the prepaid return of any item under this warranty provision and compliance with such instruction shall be a condition to make any claim under this warranty.

Except for the express warranty stated above, Haiku Home disclaims all warranties with regard to the products sold hereunder including all implied warranties of merchantability and fitness for a particular purpose and the express warranties stated herein are in lieu of all obligations or liabilities on the part of Haiku Home including, but not limited to, incidental or consequential damages arising out of or related to the use of the product, which are specifically disclaimed. This warranty is voided when:

- a. The original purchaser or user ceases to own the product; or
- b. The fixture is moved from its original point of installation.

## 60-Day "No Reason Necessary" return policy

The customer may return the lights for any reason or no reason at all, provided it is shipped, freight or postage paid, insured for its full value, and in its original packaging within 60 days of delivery. If the fixture is delivered in good condition, the customer will receive a refund of the invoice price less:

- Cost of shipping, handling, and insurance;
- 2. Amount charged for special orders;
- 3. Amount charged for customized parts, if any;
- Service fee and/or parts replacement fee for any fixture that is returned missing components, damaged in shipment where the damage is not covered by insurance, or that has been modified in any way. Such fees and charges will vary based upon the actual material and labor costs necessary to repair the fixture, replace missing or modified parts, and to return the fixture to its original factory condition. =



This policy applies only to products sold directly by Haiku Home. Products sold by Haiku Home Authorized Dealers are not subject to the 60-day "No Reason Necessary" policy.
